RESIDENCE PERMIT

SET UP OR PURCHASE OF COMPANY



The most effective way of obtaining a **residence permit in Belarus is through the set up or purchase of a company**. You need to get a power of attorney letter and send it to us to set up a company with you as a shareholder; after the company is set up – you will become the director of the company.

The company will have to cover your monthly taxes as being the director of the company. Once you are registered as the director of this newly formed company, **you can apply for a D-Visa at the Belarussian embassy for your initial visit**.

Once you arrive to the Belarus, our specialists will guide you along the process of **applying for the Temporary residence permit**, this is issued for a period of 1 year, after which it can be renewed.

Self–Employment in Belarus

All payments are included. **Preparation of all the required documents** for company establishment, placement as director and **residence permit in Belarus** and full management of the process from submission of documents by Legal Baltic, until the decision on granting a residence permit; personal appearance required on the day appointed for taking fingerprints.

The (non-EU) individual for whom the work permit is being obtained then has to apply for Belarus National visa (D Visa) before coming to Belarus. The application for granting Belarus National visa should be made either 1) at the Belarussian embassy in the state which issued the travel document or 2) at the Belarussian embassy accredited to the country in which applicant resides.

The visa decision, on average takes around 30 days and the visa issued will have of one year validity. Then applicant has to come to Belarus and apply for a Residence Permit in the migration department in Belarus and from that point, applicant will have the right to reside in Belarus until obtaining the residence permit (Even if applicant entrance visa expires)

although after the residence permit request submission, applicant can go back to the home country as well.

The decision in the Migration Department of Belarus will be made between 2 and 3 months time.

There are two options how to proceed, one is if the client has a tourist visa and can travel to Belarus for the process and the second one is if he can't travel to Belarus.

You need to provide Legal Baltic with a passport copy and a certified Power of Attorney letter, with these we will set up a company in Belarus for the you (takes around 1 week to process) and issue an invitation to the client on that basis (Immigration assessment takes maximum 3 weeks). With the invitation you can apply at the embassy for a Visa.

Upon arrival to Belarus, you can apply with the help of our partners for a 12 month residence permit.

If you have a tourist visa, you can arrive to Belarus and we will help you to buy/create a company, after which you would certify a Power of Attorney letter and go back to the country of origin, to wait for the official invitation of the company.

Renewal

There is no specific requirement for the, but in 12 months when prolonging the registration, the company will be reviewed and it has to have operations and paying taxes.

This means that unless a client wants and can run a real business in BY, they are better off buying the existing company and of course it is much better if they arrive to BY to do that.
